Call to Order / Quorum / Changes to Agenda

Dr. Betty Jo Foster chaired the meeting in lieu of Dr. Greg Hodges' absence. Dr. Foster called the meeting to order at 9:00 a.m. on Thursday, October 31, 2024. A quorum was present. There were no changes to the agenda.

Approval of Minutes

 Motion: Mr. Don Gibson made a motion to approve the August 1, 2024, meeting minutes. Mr. Mark Holland seconded the motion. The motion passed unanimously.

<u>Programs & Services / Advanced Learning Report</u>

Dr. Brown's report included the Advanced Learning Narrative report (Exhibit A) and the Quad Chart report (Exhibit B).

AmeriCorps Presentation

Dr._Julie Brown introduced the AmeriCorps program. She stated that the program has received over \$2.5 million in funding from the Corporation for National and Community Service (CNCS) and secured \$1.6 million in local funding. Dr. Brown added that 251 people have been enrolled in the program, with 222 successful terms of service, served 201,753 hours in the community, and earned \$558,000 in Segal Education Awards.

Ms. Dana Silicki (Advanced Learning Program Manager, Ms. Audia Harris (Program Coordinator II), and Mr. Brian Stanley (Program Coordinator II) provided a presentation encompassing AmeriCorps activities for the past 10 years. The presentation included an introduction to staff allocating time towards the AmeriCorps grants and the cost-savings of salary buyout from the grant. A brief background of AmeriCorps' purpose and terminology was given before describing IALR's specific AmeriCorps current grants (Dan River Year and REACH) and a past Serve IT AmeriCorps grant. Member benefits, service sites, partner agencies, statistics on member's service contracts, Segal Education awards earned, grant awards, partnerships, and service projects were shared. Videos from current AmeriCorps members detailing the impact of their service were shown.

Dr. Julie Brown discussed the expansion of the AmeriCorps program, including new initiatives in disaster services and mental health. The Institute is partnering with God's Pit Crew for disaster services and plans to implement a pre-apprenticeship model for AmeriCorps members. The

program will merge its education and public health components into one grant, with pre-approval for \$577,800 in funding for the following year.

Workforce Development Initiatives

Dr. Brown presented information on various workforce development initiatives, including the Go Tec program and efforts to address healthcare workforce shortages. Partnerships with local organizations and schools were mentioned to provide training and apprenticeship opportunities.

Community Care Hub Proposal

Dr. Brown presented a plan to renovate a 9,000-square-foot space owned by SOVA Health to create a community care hub. The hub would house community health workers, provide training spaces for healthcare professionals, and offer community meeting spaces. The estimated cost for renovations would be approximately \$700,000, with potential funding sources including Virginia Tobacco Region Revitalization Commission (TRRC) funds and innovation funds from the Danville Regional Foundation.

Space Utilization and Future Plans

Dr. Brown discussed reimagining the institute's existing lab space to make it more efficient and suitable for the Governor's School, workforce training programs, and controlled environment agriculture classes.

Open Discussion of Concerns, Issues, and Observations

No concerns, issues, or observations were discussed.

Dr. Foster adjourned the meeting at 10:35 a.m.



UPCOMING of INTEREST / Support from the BOT

- The Application Window for V-TOP's "Top Virginia Employers for Interns" Awards is open through Feb. 28th. Please encourage all businesses and organizations hosting interns to APPLY.
- The EmPOWER team is currently recruiting organizations that would be interested in hosting a Danville or Pittsylvania County High School student as a part of the Summer Internship program. Those interested in hosting an intern should contact Kiana Dillard kiana.dillard@ialr.org.
- VTOP's Matching Funds program provides a 50% match of a post-secondary intern's wage, including FICA, and a 50% match of additional workplace subsidies, such as housing, transportation, clothing, etc. The program will match up to four interns annually for three academic terms or 12 consecutive months per eligible employer. The program offers grant awards limited to reimbursement, not exceeding \$7,500 per intern or a maximum one-year limit of \$30,000 for up to four interns. The program also has a match limit of \$60,000 for two years.
 - Businesses of 150 or fewer employees are eligible (State & local governmental agencies are not eligible at this time.)
